

Three \$500 Scholarships Available to Members or Future Linemen

Guthrie County REC is continuing its commitment to community by announcing the availability of three \$500 scholarships for **individuals enrolled full-time at an accredited college, university or vocational/technical school for the 2012-2013 school year**. Our scholarship program requirements are as follows:

- 1.) All completed applications will receive consideration. There will be no discrimination on the basis of age, sex, race, national origin, creed, religion, marital status or disability.
- 2.) The recipient shall be a student enrolled in a full-time undergraduate course of study at an accredited college, university or vocational/technical school. The recipient shall be emphasizing study in the field of business, electronic technology, electric engineering, agriculture engineering, or power line program.
- 3.) The recipient shall be a U.S. citizen or resident alien in a power line program or with a membership in Guthrie County REC. This includes those individuals who are family members of directors or employees of Guthrie County REC.
- 4.) All applications shall be completed in full and filed with the Guthrie County REC Scholarship Committee. Incomplete applications will not be considered.
- 5.) The applicant shall **furnish your most recent academic transcript** whether it is from a high school, college, university, or trade school. Current College Freshman - Committee will screen and require more than one semester or quarter of grades. If this applies **also submit your high school transcript**. All transcripts shall be retained by the Scholarship Committee whether or not the applicant is granted a scholarship. All information supplied by the applicants will be considered confidential and will only be viewed by the Cooperative's Scholarship Committee.
- 6.) Applications must be postmarked on or **before April 13, 2012**. Due to the volume of applications expected, **only students awarded a scholarship will be notified by mail**. Scholarship winners will be posted in the REC headquarters by Friday, May 4, 2012.
- 7.) Scholarships will be paid in one disbursement. Eligibility for the disbursement must be confirmed before the check is issued (i.e., student must provide enrollment documentation, GPA confirmed).
- 8.) Scholarship checks will be made payable to the student. Checks must be used for educational costs. Recipient should contact the Guthrie County REC at the conclusion of 1st semester and the check will be issued.
- 9.) **A personal letter stating your educational goals is extremely important to the Scholarship Committee and must accompany the application form**. Please be sure to include financial need, any special circumstances surrounding the application, work experience and goals. **We would also be interested in a statement on why rural electric cooperatives are important**. Please limit the personal letter and statement on electric cooperatives to two typed pages. An additional page may be utilized for listing any community and/or extracurricular activities, achievement, and/or honors.
